附錄

使命宣言

香港友愛會 (PFA) 的使命是為了透過定期探訪和寫信來表達支持香港在囚人士。本會認為,這些行動為在囚人士帶來了好處,當他們在拘留、還押期間給與支持,並為未來帶點 考閱。

香港友愛會規則

為了維護本會的完整性並確保我們能夠繼續履行我們的使命,成員同意遵守以下規則:

會員應盡力與指定在囚人士保持定期聯繫。如果會員無法再履行服務,會員應通知執行委員會 (ExComm),以便為在囚人士指派新會員並繼續為在囚人士提供服務。 香港懲教署(CSD)每年要求成員進行一定次數的探訪,才能更新探訪證。

會員必須維護香港的法律,不得透過討論去鼓勵破壞法律或違反監獄規定的行為。

會員必須遵守 CSD 的規則並遵守 CSD 官員的任何指示。

只能透過 PFA 郵寄地址與在囚人士聯繫。會員不得向在囚人士提供任何個人聯繫方式。

會員不得聯絡在囚人士的家人朋友或代表在囚人士傳送或接收訊息或其他通訊給任何家庭成員或其他第三方。

會員可依照CSD的指引,向在囚人士遞交物品,但這並非義務,會員應注意不要以此作為建立關係的基礎。會員不得主動提出給予或同意接受CSD允許的條款以外的任何禮物、財務付款或其他好處,也不得透過懲教所上交以外的管道提供。

會員可以與在囚人士討論宗教事務(如果這是在囚人士的意願),但不得將宗教職責作為其 PFA 服務的一部分。

會員不得利用其會員資格從事 PFA 範圍以外的活動。不允許進行諮詢、教學、培訓、提供法律或宣傳建議或履行宗教職責等活動。

會員必須對與在囚人士的討論和關係保密。不得向他人或在公共管道透露在囚人士的詳細資料或他們的談話或信件。即使在囚人士同意或要求公開,該規則也適用。

在囚人士獲釋後,PFA為他們提供的服務就結束了,會員不應安排在監獄外與他們會面。當在囚人士獲釋後或在囚人士被轉移到香港以外的懲教所時,會員不應與 在囚人士保持聯繫。

會員可以向執行委員會成員提出對其 PFA 工作任何方面的任何疑慮或問題。 ExComm 成員都是經驗豐富的義工,將提供適當的建議和支持。會員必須遵循執行委員會成員的指導。

為了資助本會的行政開支,所有會員必須按時繳納會員年費。

個人資料收集和私隱政策聲明

香港友愛會(PFA) 致力於遵守《個人資料(私隱)條例》下 DPP 1(3)和 DPP 5 的要求,以保護我們所持有的個人資訊的機密性和安全性。

從您那裡收集的資訊將用於管理您的 PFA 會員資格、了解您作為會員的興趣和空閒時間、與您保持聯繫、將在囚人士的郵件轉發給您以及向香港懲教署申請探訪或探訪的許可。 寫信給在囚人士。如果沒有完整或最新的個人信息,PFA 可能無法繼續您的會員資格。

您的個人資料可能會與香港懲教署分享,以便申請香港監獄訪客通行證或獲得向在囚人士發送和接收信件的許可,以及回答與您作為 PFA 會員的活動有關的詢問。您有權請求存取或修改您的資料或請求將其刪除。請聯絡 PFA 主席。

APPENDIX

Mission Statement

The Prisoners' Friends' Association (PFA) exists to support persons in custody in Hong Kong through friendship demonstrated through regular visiting and writing letters. The organisation believes that although these actions provide benefit to prisoners by demonstrating support while they are in custody and providing hope for the future in a world that still cares.

PFA Rules

To preserve the integrity of the organisation and ensure we can continue with our mission, members agree to observe the following rules:

Members should do their best to maintain regular contact with persons who are assigned. If they can no longer carry out their duties they should inform the Executive Committee (ExComm) so that a new member can be assigned to the prisoner and continue to provide support to them. The Correctional Services Department (CSD) requires a certain number of visits annually in order to renew a member's visiting pass.

Members must uphold the laws of Hong Kong and must not bring PFA into question by discussing topics that could appear to encourage actions that undermine the law or go against prison regulations.

PFA members must follow the rules of the CSD and abide by any instructions given by CSD officers.

Contact with prisoners must only be through the PFA mailing address. Members must not provide any personal contact details to prisoners.

Members must not contact prisoners' families or transmit or receive messages or other communications on behalf of prisoners to any family member or other third party.

Members may hand in articles for prisoners in line with CSD guidelines, but this is not an obligation and members should be careful that this does not become the basis for the visiting relationship. Members must not offer to give, or agree to receive, any gifts, financial payments or other benefits outside of the permitted CSD articles or through channels other than handing in at a prison.

Members may discuss religious matters with prisoners (if this is the wish of the prisoner) but may not promote or perform religious duties as part of their PFA volunteering.

PFA members may not use their membership to perform activities outside of the PFA's scope. Activities such as counselling, teaching, training, giving legal or advocacy advice, or performing religious duties, are not allowed.

Members must keep their discussions and relationship with prisoners confidential. They must not disclose details of prisoners or their conversations or letters to others or on public channels. This rule applies even if the prisoner agrees to or requests publication.

After a prisoner is released the PFA's service to them ends and members should not arrange to meet them outside prison. Members are not normally expected to keep contact with prisoners after release or in the event the prisoner is transferred to a prison outside Hong Kong.

Members can raise any concerns or questions about any aspect of their PFA work with a member of the ExComm. Members of ExComm are experienced volunteers and will provide appropriate advice and support. Members must follow the guidance given by ExComm members with respect to any issues in their work.

In order to fund the administrative expenses of the organisation, all members must pay the annual membership fee on time.

Personal Information Collection and Privacy Policy Statement

Prisoners' Friends' Association (PFA) is committed to protecting the confidentiality and security of the personal information we hold by complying with the requirements of the DPP 1(3) and DPP 5 under the Personal Data (Privacy) Ordinance.

The information collected from you will be used for the purposes of managing your membership of the PFA, understanding your interests and availability as a member, keeping in contact with you, forwarding mail from prisoners to you, and applying to CSD for clearances to visit or write to prisoners. Without complete or up-to-date personal information PFA may be unable to continue your membership.

Your personal data may be shared with CSD for the purpose of applying for a prison visitor pass or to obtain permission to send and receive letters to prisoners, and to answer enquiries in connection with your activities as a PFA member.

You have the right to request access or amendment to your data or to request its deletion. Please contact the PFA Chairman.
